Services We Provide

Southern Arizona Legal Aid, Inc. (SALA) is a private, non-profit law firm.

Our services can include:

- Legal advice and counseling about your rights and responsibilities
- Limited assistance such as help with filling out legal documents
- Representation in court
- Self-help classes and clinics
- Referrals to pro bono attorneys

Who can get help?

Low-income residents within our service area. We place a high priority on serving victims of crime. Please apply if you're not sure if you qualify for our services.

Service Areas

Family Law

Orders of Protection, divorce, parenting time, guardianship, child support, and paternity.

Consumer Protection

Bankruptcy, deceptive and predatory lending practices, debt collection, vehicle repossession, fraud, and wage garnishment.

Housing

Evictions, subsidized housing, substandard housing conditions, lockouts, utility shutoffs, foreclosure, and mobile home repossession.

Public Benefits

SNAP/Food Stamps, AHCCCS Medical Assistance, ALTCS (AZ long term care), TANF Cash Assistance, Unemployment and Social Security benefits.

Immigration

Help with legal permanent resident status, removal of conditions, protection from deportation, and work authorization for persons who are survivors of domestic violence, sexual assault, trafficking, and other crimes.

Marijuana Expungement

Expungement or sealing of past eligible marijuana convictions.



Native American Services

SALA's tribal liaison makes connections with 11 of Arizona's 22 tribal nations.

SALA assists tribal members and residents in each of our service areas, as well as cases involving one's status, Indian Child Welfare Act (ICWA) cases, Indian wills, probate, guardianships, and conservatorships. Most of our practice occurs on or around the reservation; our criminal practice is exclusively limited to Tribal Court.

Accessibility Services

SALA prohibits discrimination in our programs, services, activities or employment based on race, color, religion, sex, national origin, age, and disability under the Civil Rights Act of 1964, the Americans with Disabilities Act of 1990, Section 504 of the Rehabilitation Act of 1973, and the Age Discrimination Act of 1975.
