Am I eligible for services?

In general, we serve clients who are low income. If you are not sure, please apply and we can check. We do place a high priority on serving victims of crime.

Accessibility

Under Titles VI and VII of the Civil Rights Act of 1964 (Title VI and VII) and the Americans with Disabilities Act of 1990 (ADA) Section 504 of the Rehabilitation Act of 1973 and the Age Discrimination Act of 1975, SALA prohibits discrimination in admissions, programs, services, activities or employment based on race, color, religion, sex, national origin, age, and disability. SALA will make a reasonable accommodation to allow a person with a disability to take part in a program, service, or activity. Auxiliary aids and services are available upon request. For example, this means that if necessary, SALA will provide sign language interpreters for people who are deaf, a wheelchair accessible location, or enlarged print materials. It also means SALA will take any other reasonable action that allows you to take part in and understand a program or activity, including making reasonable changes to an activity.

If you believe that you will not be able to receive services because of your disability, please let us know of your disability needs in advance if at all possible. About Us: Who We Are

Southern Arizona Legal Aid, Inc. (SALA) is a private, non-profit law firm, providing quality civil legal assistance in Southern Arizona since 1951.

We are committed to ensuring that low income community members have access to civil legal aid because we know that equal access to justice promotes family stability, strengthens neighborhoods, and improves the quality of life for all our communities.

Services: How We Can Help

Do you have a civil legal problem?

For example:

- Are you facing the loss of your home from eviction or foreclosure?
- Are you caring for grandchildren who need to register for school or visit a doctor?
- Have you had public benefits denied?
- Are you having difficulty paying bills?

These are civil legal issues, and we may be able to help!

Note: Video conferencing is available so you may not have to come into an office for services after you apply.

Range of Services

Services can include:

- Legal counseling and advice concerning legal rights and responsibilities
- Limited assistance such as help with completing legal documents
- Self-help classes and clinics
- Referrals to pro bono attorneys
- Representation in court

Areas of Law

SALA regularly assesses local civil legal needs to ensure that we are offering services that are needed in the communities we serve. Our priority areas include:

Family Law:

Our goal is to help families stay safe and stable, especially in cases involving domestic violence or where children are at risk. SALA provides assistance in cases involving divorce, parenting time, guardianship, child support, and paternity.

Consumer Protection:

Assist with consumer bankruptcy and provide assistance in cases involving deceptive and predatory lending practices, debt collection, vehicle repossessions, fraud, and wage garnishments.

Eviction Prevention/Unsafe Housing/ Home Loss:

Assist tenants with evictions from subsidized or private housing, substandard housing conditions, lockouts, and utility shut offs. SALA also helps homeowners in cases involving loss of home due to foreclosure and mobile home repossession.

Public Benefits:

SALA protects your access to public benefits, including SNAP (Food Stamps), AHCCCS Medical Assistance, TANF Cash Assistance, Unemployment and Social Security Disability benefits.

Immigration:

Helping clients achieve more stable immigration status in cases involving domestic violence, sexual assault or other crimes.

Begin Again Expungement Project:

This project assists community members in obtaining expungement of their past Marijuana Convictions for certain charges involving Marijuana under specific amounts as defined in A.R.S. Sec. 36-2852. To apply for services, call 520-623-9465 Ext 4420 or email Expunge@sazlegalaid.org

Native American Practice

SALA provides civil legal assistance in eleven Native American communities: Gila River, Salt River Pima-Maricopa, Ak-Chin, Ft. McDowell Mohave-Apache, Pascua Yaqui, San Carlos Apache, Tohono O'odham, Cocopah, Ft. Yuma, Ft. Apache, and Camp Verde Yavapai-Apache.

SALA assists tribal members and residents in each of the categories listed here, as well as with Indian wills, probates, guardianships and conservatorships. Most of our practice occurs on or around the reservation, and our criminal practice is exclusively limited to tribal court.



Getting Involved Volunteer Lawyer Program (VLP)

SALA's dedicated team of attorneys (covering 9 counties) is too small to meet all the civil legal needs of our community. One of the ways we expand our services is through our Volunteer Lawyer Program (VLP).

Through VLP, pro bono attorneys provide assistance to clients through self-help clinics and classes, and, as needed, direct referrals to pro bono lawyers. For more information on our VLP program (and about other volunteer opportunities) visit our website: www.sazlegalaid.org
